WHEREAS, Boards of County Commissioners pursuant to N.C.G.S. 153A-233 are authorized to designate fire districts or parts of existing districts and prescribe the boundaries thereof for insurance grading purposes; and

WHEREAS, the Town of Canton provides fire protection services for the East Canton and West Canton fire service districts established pursuant to N.C.G.S. 153A-302; and

WHEREAS, the Office of the State Fire Marshal requests the area included in the East Canton and West Canton fire service districts to be included in the Canton Rural Fire Insurance District for insurance rating purposes; and

WHEREAS, the Haywood County Fire Marshal has caused to be created new fire insurance district map using the GIS system for the area to be included in the Canton Rural Fire Insurance District reference into Exhibit A to this resolution;

NOW THEREFORE BE IT RESOLVED that the Haywood County Board of Commissioners approves the boundary lines of the Canton Rural Fire Insurance District, exclusive of current or future municipal town limits, and as represented in the GIS produced map certified by the Haywood County Fire Marshal referenced in Exhibit A.


