



SUBJECT: Appointment of Haywood County TDA 1% Zip Code Subcommittees

REQUEST: Request that the Commissioners approve the appointments to the 1% Zip Code Subcommittees as recommended by the municipalities.

BACKGROUND: As established by the Board of County Commissioners in February of 2008, the Haywood County Tourism Development Authority 1% Zip Code Subcommittees were appointed to review and recommend grant funding allocations for all eligible applications received for 1% Occupancy Tax funding in the five zip code areas of Haywood County. Recommendations for grant funding are submitted to the Haywood County Tourism Development Authority Board of Directors for approval. The HCTDA Board has the final authority on allocation of the 1% grant funds. All 1% grant funds are included in the HCTDA annual budget.

Zip Code areas collecting less than \$50,000 have a 3 person Subcommittee and Zip Code areas collecting more than \$50,000 have a 5 person Subcommittee.

The terms of the 1% Subcommittee appointments are for two year terms beginning January 1, 2016 thru December 31, 2017. Recommendations for the 1% Subcommittee appointments are as follows:
