Grant Activities and Reports:

All expenditures will be tracked via generally accepted accounting principles of Haywood County government.

All expenditures will be made immediately after funds are drawn down to Haywood County accounts.

All goals and objectives should be completed within one year of fund draw down.

Performance measures for safety related enhancements will be based on reports made by the individual officers and surveys conducted by the leadership of the Haywood County Sheriff's Office.

Haywood County is the third largest county in western North Carolina after Buncombe and Henderson Counties. Approximately 50 miles of the historic Blue Ridge Parkway travels through Haywood County, with an estimated 15 million visitors traveling the Parkway annually. Haywood County is also the home of the I-40 corridor coming into North Carolina and is also a main thoroughfare for Atlanta, Asheville, and Cherokee. The Haywood County Sheriff's Office is responsible for all calls for service in the county other than the four separate jurisdictions: Waynesville (County seat), Maggie Valley, Canton, and Clyde. Those jurisdictional areas make up approximately 16000 of the county's population.
