SUBJECT: Prospective members for HCHHSA Board

REQUEST: Seeking approval from the Board of County Commissioners to appoint Dan Schultz and John Stoeckel to the HHS Board.

BACKGROUND: There has been an unexpected vacancy of the Social Worker position on the HHS Board due to a Board member moving from the area. While the plan was to fill the one position, the posting for the position netted applications by two very qualified candidates who would each bring extremely positive and helpful experience to the Board, as well as helping to bring more balance between Human Services and Health representation on the Board. Given the structure of the consolidated Health and Human Services Board, there is room to add both: one as Social Worker member and one as a Public Member. The candidates have been reviewed, interviewed and vetted by the HHS Board Personnel and Nominations Committee on October 11, 2016, as well as by the full HHS Board on October 18, 2016. The HHS Board now respectfully requests approval by the Board of County Commissioners of these appointments to the HCHHSA Board. The two candidates are:

Dan Schultz, a caseworker and licensed clinical social worker for 13 years and supervisor and administrator for 23 years, with a focus on program assessment and child welfare, and is currently retired. The Board respectfully requests that he be appointed as the Social Worker member. As such, he will be completing the remaining three years of the four-year term vacated by Tony Beaman, which expires 11-17-19.

John Stoeckel, a contractor with Senior Life Solutions providing mental health services through Duke Lifepoint. Mr. Stoeckel began a career in law enforcement before moving into social work. He has extensive experience with addiction services and has also worked extensively with seniors. The Board respectfully requests that he be appointed as a Public Member. Upon appointment, Mr. Stoeckel would serve a four-year term beginning the date of his swearing in.

IMPLEMENTATION PLAN:

Upon approval of the appointments by the Board of County Commissioners, the two applicants will be sworn in at the HCHHSA Board meeting on November 17th, 2016
