RESOLUTION
HAYWOOD COUNTY BOARD OF COMMISSIONERS
REGULAR MEETING
NOVEMBER 21, 2016

WHEREAS, at the November 8, 2016 General Election, an ABC referendum proposition containing five (5) ballot issues involving various types of sales of malt beverages and unfortified wine was passed by a majority of votes; and

WHEREAS, N.C. General Statutes Section 18B-904 (f) permits the Board of County Commissioners to designate an official by name or office to make recommendations or register objections to the State Alcohol Control Commission ("ABC Commission") concerning suitability of a person or location for an ABC permit; and

WHEREAS, the aforesaid statute requires the Board of County Commissioners to notify the ABC Commission of such designation; and

WHEREAS, the person or official so designated shall follow the guidance or rules of the ABC Commission as to suitability of a person for receipt of a permit, the factors to be considered being set forth in N.C. General Statutes Section 18B-901(c); and

WHEREAS, the person or official so designated shall complete and return the Local Government recommendations and compliance forms required by the ABC Commission; and, after consultation with the Board of County Commissioners and consideration of the factors listed in N.C. General Statutes Section 18B-901 (c), make recommendations to the ABC Commission based on suitability of the proposed permit location.

NOW THEREFORE, BE IT RESOLVED:

1. That Ira Dove, Haywood County Manager, is hereby designated pursuant to NCGS Section 18B-904(f) to make recommendations or register objections to the ABC Commission concerning suitability of a person or location for an ABC permit, pursuant to the guidelines of the ABC Commission and the provisions set forth above in this resolution.
2. That the said County Manager shall so notify the North Carolina ABC Commission.
3. That the Board of County Commissioners shall be advised upon the receipt of an application for permit, as set forth in NCGS Section 18B-901(b).

THIS RESOLUTION IS HEREBY ADOPTED THE DATE SET FORTH ABOVE UPON A VOTE OF THE MAJORITY OF THE BOARD OF COUNTY COMMISSIONERS AS SPECIFICALLY SET FORTH IN THE MINUTES OF THE MEETING.
