Use of Unauthorized Substance tax monies

REQUEST:

To make use of \$27,000.32 of the unauthorized substance tax monies for the purchase of equipment/ballistic body armor for use in the enforcement of illegal drug and criminal activity by the Haywood County Sheriff's Office.

BACKGROUND:

The use of the unauthorized substance tax monies can be used to allow the Office of the Sheriff to update equipment through the purchase of enhanced body armor necessary to further the ongoing illegal drug enforcement and criminal activities within Haywood County. This will serve to better protect deputy sheriffs from potentially dangerous situations.
